## **Agreement on Public Offer for Donation**

- 1. This Public Offer for Donation (hereinafter referred to as the Offer) is aimed at any individual responding to the Offer (hereinafter referred to as the Donor) and is a public proposal of IStories Fonds (hereinafter referred to as the Donee) to conclude the agreement on donation (hereinafter referred to as the Agreement) in any form convenient on the following terms.
- 2. This Offer is a Public Offer Agreement that has been formulated in line with Point 2 of Article 437 of the Civil Code of the Russian Federation.
- 3. The Offer enters into force on the day following the publishing of the Offer by the Donee on the official website: istories.media (hereinafter referred to as the Website).
- 4. The Offer is valid indefinitely. The Donee retains the right to cancel the Offer at any point without explanation. The Donee retains the right to introduce amendments or additions to the Offer at any time. These amendments or additions will come into force on the day following their publishing by the Donee on the Website. The nullification of one or more of the terms of the Offer does not render the remaining terms of the Offer invalid.
- 5. The Offer is issued and the agreement is concluded in Moscow, Russia.
- 6. This Offer is regulated and interpreted in accordance with Russian legislation.
- 7. By agreeing to this proposal, the Donor gives their permission to receive transactional notices from the Donee confirming the completion of the payment.
- 8. The Donor voluntarily transfers ownership of funds in an amount of the Donor's choosing to the Donee for the purposes outlined in Point 9 of this proposal.
- 9. Intended use of the donation: Funds received by the Donee are to be used to carry out statutory activities and maintenance.
- 10. The date of acceptance of the Offer and the date of conclusion of the agreement is the date on which the funds are sent by the Donor to the account of the Donee.
- 11. The Donee has the right to cancel the donation at any point up to the moment of and for fifteen days after the transfer of funds from the Donor. In the event that the Donee rejects the donation after the transfer has taken place, the Donee must return the donation within fifteen days of the decision to reject it. In the event that the Donee is unable to return the donation to the Donor, the donation remains at the disposal of the Donee.
- 12. The Donor has the right to cancel the donation within fifteen days of the completion of the transaction. The Donor will notify the Donee about their wish to cancel the donation by electronic mail using the following address: <a href="mailto:letter@istories.media">letter@istories.media</a> The Donee undertakes to return the funds to the Donor within fifteen days of receiving the Donor's notification.
- 13. By undertaking the actions stipulated by this proposal the Donor confirms that they have read the terms and the text of this proposal, are aware of the purposes of the Donee's activities, acknowledge the significance of their own actions, have the right to fulfil these actions, and fully accept the terms of this proposal.

14. In accordance with Russian Federal Law No. 152-FZ "On Personal Data" the Donor hereby consents to the processing of their personal data by any means not prohibited by law for the purposes of executing this proposal.
